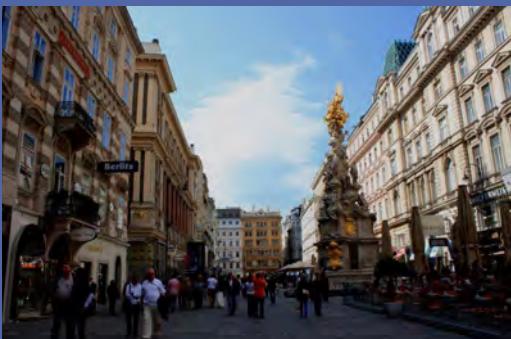

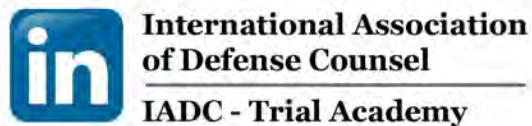
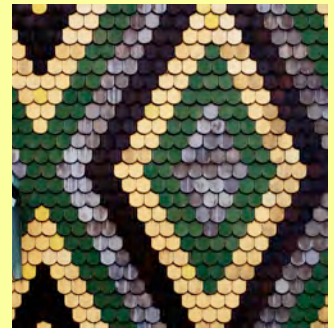

Disclosing Chemical Use is More Than a REACH - It is a Tough Global Stretch

The inherent problems of complying with divergent regulatory regimes that contradict or lack consistency of terms ("miles vs. metres") as well as coordination with subsidiaries without running afoul of anti-competitive laws and potential product liability exposure are just part of the myriad concerns inherent in this dynamic. This program will examine the interplay between EU's REACH scheme for the regulation of chemical substances and its counterparts in the U.S. and examine whether these EU regulatory schemes have the potential to create liability exposure for manufacturers in the U.S.

Superpower Illusions: How Myths and False Ideologies Led the U.S. Astray - And How to Return to Reality

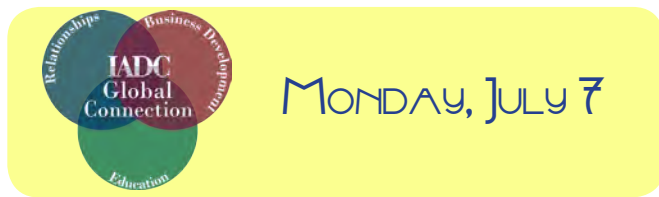


Former U.S. Ambassador to the USSR Jack F. Matlock refutes the enduring idea that the United States forced the collapse of the Soviet Union by applying

military and economic pressure - that resulted in wide-ranging implications for U.S. foreign policy. Mr. Matlock argues that Gorbachev, not Reagan, undermined Communist Party rule in the Soviet Union and that the Cold War ended in a negotiated settlement that benefited both sides. He posits that the end of the Cold War diminished rather than enhanced U.S. power; with the removal of the Soviet threat, allies were less willing to accept U.S. protection and leadership that seemed increasingly to ignore their interests.

Mr. Matlock shows how, during the Clinton and particularly the George W. Bush administrations, the belief that the United States had defeated the Soviet Union led to a conviction that it did not need allies, international organizations, or diplomacy, but could dominate and change the world by using its military power unilaterally. The result is a weakened U.S. that has compromised its ability to lead. Mr. Matlock makes a passionate plea for the United States under Obama to reenvision its foreign policy and gives examples of how the new administration can reorient the U.S. approach to critical issues, taking advantage of lessons we should have learned from our experience in ending the Cold War.

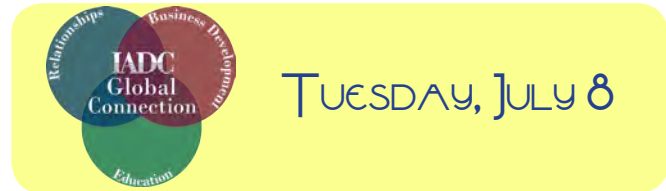

Concussion (MTBI) in Sport, MVA and Other Incidents: A Looming Liability Claim - What is It, How is It Caused, and What Do We Know?

The National Football League (“NFL”) recently settled a multi-million dollar consolidated lawsuit brought by retired players over concussion-related traumatic brain injuries. Lawsuits seeking monetary recovery for concussive injuries extend beyond the NFL to other sports (hockey and European futbol), motor vehicle crashes, and even slip and fall accidents. In this session, IADC member Kyle Dreyer will conduct an interactive direct examination of Dr. David Viano, former co-chair of the NFL’s MTBI committee. The examination will address the causes of and risks for concussion. They will discuss the biomechanics of concussion using, among other things, the analysis and reconstruction of NFL concussion injuries from helmet impacts. They will also discuss new testing designed to help reduce the risks of brain injury and confounding factors that could offset gains in advanced technology protection (the speed and size of players). A focus will be on head accelerations and the effect of head acceleration on the brain. Mr. Dreyer and Dr. Viano also will provide information about the medical signs and symptoms of concussive injury, describe a basis for discriminating real from contrived claims, and provide insight into the growing number of medical facilities that endorse concussion claims made by those who have had low head accelerations but claim life changing injury to their brain. In other words, what do you do when the medical evidence shows no definable brain pathology but the plaintiff claims neuropsychological or neurological dysfunction and some medical professionals support the claim of permanent changes in cognitive ability and behavior?

The Future of Legal Services

Richard Susskind contends that three drivers of change – cost, liberalization, and information technology – will combine in the coming decade to transform the way in which legal services are provided. He will review how it will become commonplace to decompose legal work into component tasks and source these tasks in a wide variety of ways, from legal process outsourcing to setting up low cost legal services centres. Looking long term, Susskind analyzes that the Internet, artificial intelligence, and various other emerging technologies will dominate the delivery of legal services. Given the scale and impact of the changes he anticipates, we will need stronger leadership and management across the legal world.

Professor Richard Susskind, OBE, is an author, speaker, and independent adviser to major professional firms and to national governments. His main area of expertise is the future of professional services and, in particular, the way in which the IT and the Internet are changing the work of lawyers. He is President of the Society for Computers and Law, IT Adviser to the Lord Chief Justice of England, and Chair of the Advisory Board of the Oxford Internet Institute. Richard lectures internationally and has been invited to speak in more than 40 countries. He has addressed audiences, in person and by video link, numbering more than 300,000. He has written eight books, including the bestsellers, *The End of Lawyers?* (OUP, 2008), and *Tomorrow's Lawyers* (2013), and has written around 150 columns for *The Times*. His work has been translated into 10 languages. He holds professorships at Oxford University, UCL, London, Gresham College, and Strathclyde University, and he has a doctorate in law from Balliol College, Oxford.

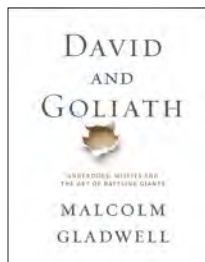

BOOK REVIEW

David and Goliath: Underdogs, Misfits, and the Art of Battling Giants by Malcolm Gladwell

Three thousand years ago on a battlefield in ancient Palestine, a shepherd boy felled a mighty warrior with nothing more than a stone and a sling, and ever since then the names of David and Goliath have stood for battles between underdogs and giants. TIERGARTEN ZOO



Built on the site of Franz Stephan's royal menagerie (1752), on the western side of the gardens, the Tiergarten is the world's oldest zoo. The habitats are laid out around the 18th-century central octagonal pavilion (once the imperial family's breakfast room), while many of the original Baroque buildings and displays are still in use, alongside more modern enclosures. Attractions include a polarium and rainforest house, but the Giant Pandas are the stars of the show. For more information, visit www.zoovienna.at.

AMUSEMENT PARK/FERRIS WHEEL

Vienna's landmark amusement park features the familiar 65 meter high giant ferris wheel that towers over the park's 200 booths, ghost train, go-karts, and merry-go-rounds, plus a planetarium and the Prater Museum. No trip to Vienna is complete without a ride on the 19th-century Riesenrad or giant ferris wheel that is featured in *The Third Man*. It's the only remaining work of British engineer Walter Basset who also built wheels for Blackpool, London, and Paris. It was completed in 1897 to commemorate the Golden Jubilee of Franz Josef. A full circle in one of the 15 wooden gondolas takes a gentle 20 minutes, and at its highest point you are 65 meters (213 feet) up. DANUBE RIVER/BEACHES

On the banks of the Danube, on either side of the Neue Donau channel, you will find the beaches of Vienna. Accessible via the city's subway system, the Alte Donau has paying beach clubs such as the sprawling Gänsehäufel, which in addition to beach access also has a large swimming pool. VIENNA'S WINE "COUNTRY"

The seven square kilometers of vineyards that lie within its boundaries make Vienna the world's largest wine-growing city. The most extensive area is on the northern fringe in districts 16-19, but the highest quality vines lie over the Danube in the 21st district. On summer evenings, join the Viennese for an evening in a Heuriger, one of the scores of rustic wine taverns dotted among the vineyards that skirt the Vienna Woods. GENERAL INFORMATION

VIENNA

There are many reasons to visit Vienna - the city is world famous for its imperial heritage, Schönbrunn Palace, the Belvedere, and the Hofburg. This capital city scores highly thanks to the first-rate musical and cultural attractions at its concert halls, museums, and theaters - from the Golden Hall of the Musikverein to the acclaimed Museum of Fine Arts to the State Opera House. Vienna is also a byword for epicurean enjoyment, with centuries of traditions shaping its coffee houses and Heuriger wine taverns. Over half of the city is accounted for by green spaces including parks and gardens, the Vienna Woods, and the wetlands of the Donau Auen National Park.

AUSTRIA ENTRY REQUIREMENTS

Austria is a member of the European Union, but entry from non-European Union countries is not a problem. However, there are a few things regarding entry and customs regulations which one should be aware of (see below).

Austria is a member of the European Union and the Schengen Convention. EU-citizens require an official ID to enter Austria. Citizens from non-EU countries are advised to obtain information about the regulations governing entry into Austria applicable to their country before starting their trip. For U.S. and Canadian attendees, a valid passport is required for entry. While there are no border controls between Schengen countries, it is still mandatory to carry an ID.

CUSTOMS REGULATIONS

For EU citizens, the regulations applicable within the European Union apply. Travelers from non-European countries require a valid passport that entitles them to a three-month stay in Austria. Visitors from these countries may only import “personal travel goods” customs-free, i.e. such goods as they need on a temporary basis for their personal use or consumption or to exercise their profession.

CURRENCY

As a member of the European Union, Austria’s common currency is the Euro.

ATMS

ATMs are widely used in Austria and are called “Bankomat.” You will find outdoor venues at most branches of Austrian banks. Please check with your local bank if your bank card is equipped with the necessary codes. A four-digit PIN is also required to access an ATM.

CREDIT CARDS

Credit cards, although accepted in hotels, major restaurants, and stores, are less used for purchases in small shops, cafes, or grocery stores.

VIENNA CARD

With the Vienna Card (€19.90), sponsored by the Vienna Convention and Visitors Bureau, you will have access to more than 200 discounts and unlimited free travel by underground, bus, and tram for a 72 hour period. For more information, visit www.wien.info/en/travel-info/vienna-card.



AIRPORT

The Vienna International Airport (VIE), located approximately 20 minutes from the Hilton Vienna, has daily flights to Europe's leading cities and extensive international connections including these non-stop flights on Austrian Airlines, a member of the Star Alliance, from North America: Chicago, New York (JFK), Newark (beginning July 2014), and Washington, DC.

TRANSPORTATION TO/FROM THE HILTON VIENNA

The Hilton Vienna has a direct airport connection via the city airport train (CAT), opposite the hotel. You can also take the 'Scnellbahn' heading for Floridsdorf. Exit the station at Wien Mitte, which is directly across the street from the hotel.

City taxis are easily accessible at the airport just steps away from the baggage claim area. The average rate for a transfer from the airport to the hotel is €35.00. An additional surcharge may apply in the event of excess luggage.

A CASH REFUND, less a \$150 processing fee, will be made if a written notice of cancellation is received by the IADC office more than thirty (30) days prior to the first day of the meeting. No reason for the cancellation need be provided for a timely notice of cancellation.

NO CASH REFUND will be made if notice of cancellation is received by the IADC office thirty (30) days or less prior to the first day of the meeting. However, if special circumstances arise before the meeting which prevents attendance, a member may request a future meeting credit. The request needs to be in writing and submitted to the IADC office. It should be directed to the Finance Committee's attention and note the special circumstance which caused the cancellation. The credit request can only apply to meeting registration fees (not air, hotel, activity, tour, or special event fees) and, if approved, will be valid for use toward any IADC meeting for one (1) year from the date of the meeting for which credit is requested. A \$150 processing fee will be deducted from the total future meeting credit.

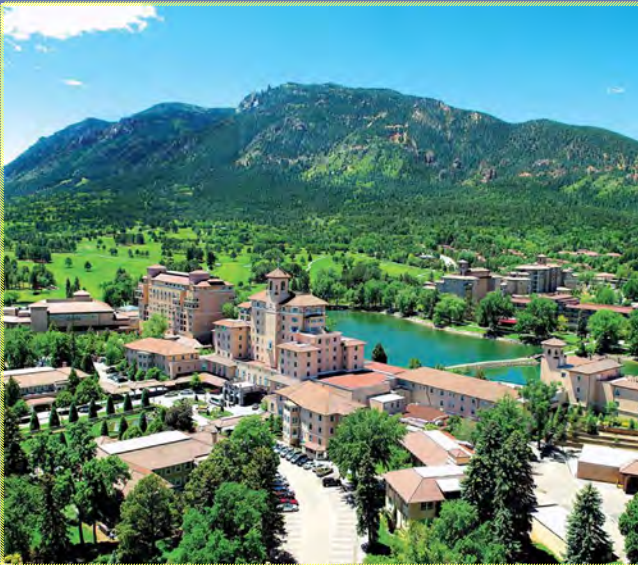
