He also has written for *The New Yorker, Vanity Fair, Rolling Stone, Business Week* and *The American Lawyer*, and published several law review articles on First Amendment topics. Prior to his work as a reporter, Mr. Liptak worked in *The Times'* legal department, where he focused on defamation, privacy, newsgathering and related issues, and frequently litigated media and commercial cases. He spent four years at Cahill Gordon & Reindel, a New York City law firm, as a litigation associate specializing in First Amendment matters. Mr. Liptak's teaching engagements include the Columbia University School of Journalism, UCLA Law School, and Yale Law School. He is a graduate of Yale University, and received his J.D. from that same institution in 1988.
