### **JOHN MYERS**

Partner, Montgomery McCracken

General Counsel, Franklin & Marshall College

Pierce has been General Counsel at Franklin & Marshall College since 2014. A graduate of Villanova University's Charles Widger School of Law, Pierce started his career with Dilworth Paxson LLP. From 2004 to 2014, he was an Associate General Counsel at University of Pennsylvania, where he concentrated on employment matters, faculty concerns, governance, and community and institutional issues. Prior to law school, Pierce was Assistant Dean of Admissions at Hamilton College. He graduated *cum laude* from Colgate University, and has a Master's degree in Medieval History from Penn.

### **BILL MARIMOW**

Vice President of Strategic Development, Philadelphia Media Network

Bill, a two-time Pulitzer Prize recipient, is Vice President of Strategic Development for The Philadelphia Inquirer's parent company, Philadelphia Media Network. Born in Philadelphia, he grew up in Havertown and joined *The Inquirer* in July 1972 as a business reporter. As a reporter at *The Inquirer*, Bill received the Pulitzer Prize for public service in 1978 for stories he wrote with a partner on criminal violence by Philadelphia police, and again in 1985, for his investigation of the police K-9 unit. His work on the bombing of the MOVE house on Osage Ave. formed the backbone of The Inquirer's Pulitzer Prize entry in 1986, which was a finalist in the general reporting category. In addition. Bill received two Silver Gavel Awards from the American Bar Association and two Robert F. Kennedy awards -- the first, for his work as an *Inquirer* reporter and, the second, for his work as vice president of news at National Public Radio (NPR). Bill has also served as the editor of The Baltimore Sun and the Vice President of News for NPR. He was Editor in Chief of *The Inquirer* from 2006 until 2010 and, again, from May 2012 until spring 2017. He is a 1969 graduate of Trinity College, and he studied First Amendment law at Harvard Law School as a Nieman Fellow in 1982-83. His wife. Diane, teaches at the Philadelphia Museum of Art and also produces her own sculpture at The Clay Studio. He has two children - Ann, a reporter at the Washington Post, and Scott, who is a principal at a private equity firm.

# **RHASHEDA DOUGLAS**

Director of the Minority Student Program , Rutgers Law School

Rhasheda has been Director of the Minority Student Program on the Camden campus of Rutgers Law since 2016. Before that she was Title IX Manager at Rowan University, where she oversaw compliance, training and outreach related to Title IX, VAWA, and sex discrimination. From 2007 to 2015, Rhasheda was a team attorney, then team leader, with the Office of Civil Rights at the Department of Education in Philadelphia. She went there from Montgomery McCracken, where she was an associate in commercial litigation and served on the firm's Hiring and Diversity Committees. She earned her J.D. from Rutgers School of Law-Camden in 2002 and a B.A. in English from Boston University in 1997. Rhasheda was a "Rising Star" in Pennsylvania Super Lawyers. Vice President for Public Safety and Superintendent of the Penn Police Department , University of Pennsylvania

Maureen came to the University of Pennsylvania in 1994 as the Director of Victim Support & Special Services and became Vice President for Public Safety and Superintendent of Penn Police in 2000. Prior to Penn, Maureen served a distinguished 18 years with the Philadelphia Police Department. She is a true trail blazer. She was one of the first 100 women police officers hired in the Philadelphia Police Department on street patrol in a court-ordered program directed by the United State Department of Justice. As a result. women are now about 25% of the Department. Maureen is a Fellow with Penn's Fox Leadership Program. She holds a M.S. degree from Penn in Organizational Dynamics. She also completed the John F. Kennedy School of Government, the Northwestern School of Staff & Command and the FBI's Law Enforcement Executive Development Programs. She was named to Security Magazine's "Most Influential People in Security" in 2015, and received the Egon Bittner Award for Excellence in Leadership of a CALEA (Commission on Accreditation for Law Enforcement Agencies) Accredited Law Enforcement Agency for 15 consecutive years in 2016.
